STANDARD RISK MEASURE CHANGES

The Standard Risk Measure (SRM) is based on industry guidance to allow investors to compare funds that are expected to deliver a similar number of negative annual returns over any 20-year period. The SRM is an indication of the risk level. The SRM may change over time for various reasons, including as a result of reviews of the underlying capital market assumptions that are used in their calculation and future changes to asset allocations by the investment manager. Any changes to SRMs at any time will be available at our website, www.perpetual.com.au. For further information, please refer to the Perpetual Wholesale Funds Product Disclosure Statement.

Following a review of the SRM for the Perpetual Global Innovation Share Fund and effective 3 May 2022, the risk level for the following funds/options has changed as below:
