This Target Market Determination ('TMD') for the **Russell Investments GSS Active 70/30 Fund** ('Fund'), is issued by Netwealth Investments Limited ABN 85 090 569 109, AFSL 230975. This TMD seeks to provide distributors with an understanding of the class of consumers for which the Fund has been designed. This document is not a summary of the product features or terms of the Fund. The information in this document is general advice only, and the TMD has been prepared without taking into account any persons' objectives, financial situation or needs. Persons interested in acquiring this product should read the Product Disclosure Statement ('PDS') for the Fund before making a decision whether to buy this product.

Description of target market

In the tables below, Column 1, Consumer Attributes, indicates a description of the likely objectives, financial situation and needs of the class of consumers that are considering this product. Column 2, TMD indicator, indicates whether a consumer meeting the attribute in column 1 is likely to be in the target market for this product.

Investment products and diversification

This product is likely to be appropriate for a consumer seeking **capital growth**. The Fund is highly diversified and designed for a consumer with a minimum 6 year investment timeframe and **high** risk/return profile.

Under normal circumstances, withdrawal requests may be made on any business day and normally processed from the Fund to a platform cash account within three business days from receipt of a withdrawal request.

 In the event that most of the Fund's investment in an Underlying Fund or Underlying Funds cannot be
 withdrawn, there would be a freeze on withdrawals from the Fund and the ability to withdraw within the usual period would be suspended. Given the nature of the investments, this is unlikely to occur except in very unusual circumstances.

Appropriateness

Netwealth has assessed the product and formed the view that the product, including its key attributes, is likely to be consistent with the likely objectives, financial situation and needs of consumers in the target market.
