About this document

This Target Market Determination ('TMD') for the **BlackRock GSS Australian Property Index Fund** ('Fund'), is issued by Netwealth Investments Limited ABN 85 090 569 109, AFSL 230975. This TMD seeks to provide distributors with an understanding of the class of consumers for which the Fund has been designed. This document is not a summary of the product features or terms of the Fund. The information in this document is general advice only, and the TMD has been prepared without taking into account any persons' objectives, financial situation or needs. Persons interested in acquiring this product should read the Product Disclosure Statement ('PDS') for the Fund before making a decision whether to buy this product.

Description of target market

In the tables below, Column 1, Consumer Attributes, indicates a description of the likely objectives, financial situation and needs of the class of consumers that are considering this product. Column 2, TMD indicator, indicates whether a consumer meeting the attribute in column 1 is likely to be in the target market for this product.

The Consumer Attributes for which the product is likely to be appropriate have been assessed using a red/amber/green rating methodology with appropriate colour coding:



Generally, a consumer is unlikely to be in the target market for the product if:

- one or more of their Consumer Attributes correspond to a red rating, or
- three or more of their Consumer Attributes correspond to an amber rating.

Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (typically with an intended product use of satellite/small allocation or core component). In such circumstances, the product should be assessed against the consumer's attributes for the relevant portion of the portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a conservative portfolio with a satellite/small allocation to growth assets. In this case, it may be likely that a product with a High or Very High risk/return profile is consistent with the consumer's objectives for that allocation notwithstanding that the risk/return profile of the consumer as a whole is Low or Medium. In making this assessment, distributors should consider all features of a product (including its key attributes).





This product is likely to be appropriate for a consumer seeking **capital growth**. The Fund is designed to be used generally as a **minor allocation** within a portfolio where the consumer has a minimum 5 year investment timeframe and **high** risk/return profile.

Distribution Condition Rationale

- 1. Material change to key attributes, fund investment objective and/or fees.
- 2. Material deviation from benchmark / objective over sustained period.
- 3. Key attributes have not performed as disclosed by a material degree and for a material period.
- 4. Determination by Netwealth that there has been a reportable significant dealing in the Fund.
- Material or unexpectedly high number of complaints about the product or distribution of the product.
- 6. Material actions by regulators in relation to deficiencies in the product or its distribution.
