Important changes to Super Accelerator

Changes to administration fees Super Accelerator Core

Effective 1 October 2023 there will be [an increase] OR [a decrease] to your Administration fee –account fee based on your current account balance.

We are writing to you in relation to your Super Accelerator account with Netwealth and to let you know that on 1 October 2023 we will be issuing a new Super Accelerator Product Disclosure Statement (**'PDS**').

We regularly review the products and services we offer our members including their associated cost. Our aim is to ensure that the fee structure remains competitive and equitable amongst members. As a result of our latest review, from 1 October 2023 the 'Administration fee – account fee' for Super Accelerator Core accounts will be replaced with a new Administration fee – account fee.

As you currently hold a Super Accelerator Core account with us, the change in fees described below will impact you.

Changes in fees for Super Accelerator Core

The Administration fee – account fee for Super Accelerator Core accounts will continue to be based on a percentage of the total account balance and, whilst we have reduced the percentage applicable per annum (from 0.35% to 0.15% p.a.), it will now apply to account balances up to \$750,000 (previously it applied to account balances up to \$250,000). In addition, a fixed amount (calculated daily at the rate of \$60 per calendar year) has been introduced and the minimum total account fee has increased from \$120 to \$225 per calendar year. The following table compares the current and new fee.

What this means to you

If you have a Super Accelerator Core account balance between \$65,000 and \$543,000 there will be a decrease in your account administration fees.

If you have a Super Accelerator Core account balance of less than \$65,000 or greater than \$543,000 there will be an increase in your account administration fees.

The current Administration fee – account fee will be charged up to and including 30 September 2023. From 1 October 2023 the new Administration fee – account fee will be in effect.

Your account balance on 21/08/2023 was \$X. Assuming your account balance remained at this level, your annual Administration fee – account fee would change from \$X to \$X p.a.

What do you need to do?

You do not need to take any action. You may wish to discuss this change with your financial adviser to understand how this may impact you. The updated PDS will be available from 1 October 2023 from 'Forms and documents' under 'Support' on our website or by contacting us.
