Trading Lots on the Tokyo Stock Exchange

From 1 October 2018 onwards, the Japan Exchange Group announced that the Tokyo Stock Exchange has shifted to a standardized trading unit of 100 shares for domestic stocks. Each trade will be required to be in multiples of 100 units.

Orders that are submitted for amounts outside the official trading lot sizes ("odd lots") may be subject to alternative trading arrangements and not have the same liquidity and pricing.
